Policies regarding use of the Dane G. Hansen Scout Reservation.

1. Usage

The Dane G. Hansen Scout Reservation has been established for the purpose of providing an outdoor setting to further the development of youth through the character building program of the Boy Scouts of America. Usage of the Hansen Reservation by Non-Scout groups whose purposes are compatible with those of the BSA is permitted at times when the camp is not in use by the Coronado Area Council or associated youth organizations. The person submitting the application for the group will be held responsible for the care of the facilities and the conduct of the group while using the property and facilities. The person in charge should arrive with or in advance of the group in order to assist with checking the group in the orienting them to the usage of the property.

2. Reservations

Reservations should be submitted at least one month prior to the date desired. Upon application and approval for usage by the Coronado Area Council, the requesting group must complete an agreement for usage and submit the following:

- A. Hold Harmless Agreement
- B. Proof of liability Insurance (\$1,000,000 w/BSA named as additionally insured).
- C. A Deposit toward Fees.
- D. (If aquatics activities are planned) Certification of qualified supervision and lifeguards.

3. Deposits & Payments

When a group wishes to complete an agreement to use Camp Hansen and have included the Hold Harmless statement and proof of insurance, they make a deposit of at least 50% of the prospective usage fee or \$100.00, whichever is more. The deposit is refundable (except \$50.00) if the group has a change in plans and notifies the Coronado Area Council at least 30 days in advance of the reserved date. The remaining portion of the Usage fee must be paid at the time of check-in at camp or before.

4. Damages

Groups should leave the facilities of camp clean and in good order. Damages caused by mis-use or carelessness are subject to reasonable charges for repair or replacement.

5. Parking

Parking is permitted only in designated areas. Once parked, vehicles should be left in parking area. Parking is not permitted in campsites, around the pool or near buildings.

6. Prohibited Substances and Activities

Alcohol beverages, illegal drugs, explosives, fireworks, firearms, ammunition, bicycles, mopeds, and ATV's, are not permitted. Smoking will be confined to areas authorized. Ground fires are not allowed. Cooking fires must be attended and liquid fuel for cooking safeguarded.

7. Aquatics

Users of the Swimming Pool must provide a qualified, certified adult supervisor and certified lifeguards. Canoes/rowboats come complete with PFD's, paddles and oars. Safety gear must be used while boating and conducted under the supervision of a certified, qualified adult.

8. Wildlife Protection

The Scout Reservation is a Game and Wildlife Preserve and care should be taken at all times not to disturb or destroy wildlife or habitats. No pets are permitted on camp property. No hunting is permitted and state laws regulating fishing apply.

9. Housing

Sleeping is permitted only in designated buildings where smoke alarms are installed. Users must observe the capacity on indoor housing and is limited to adult users. Tents are permitted only in campsite areas. Emergency shelter is available in the basement of the dining hall and/or headquarters lodge in the event of violent rain or wind storms. There is no charge for these shelters as a backup to your normal pre-registered housing plan.
