If a Lifeguard is provided by the Coronado Area Council there is a \$25.00 per hour charge paid directly to the Lifeguard by the renting group

Remember that your group must also provide a Hold Harmless Agreement and a Certificate of Liability Insurance naming the Coronado Area Council, BSA and the National Council, BSA as additionally insured for your activity.
